N.Y. Post 4/4/81 "On the matter of the mystery man in the crowd, sources said witnesses saw a man resembling Hinckley outside the D.C. Hilton and the Secret Service also quickly spotted him."

Editor and Publisher for April 11, 1981. "AP photo at Nazi rally in St. Louis in 1978 was James Gaither Whitton, also a Nazi like Hinckley, arrested in Oklahoma, 1977, distributing Nazi handbills."

"All files emptied and ordered destroyed with Whitton pictures." Exact Hinckley double, profile views.

## POSSE COMITATUS. Bnai Brith Messenger, L.A. 4/3/81

"Fundamentalist para-military Christian organization" Founded in 1974 by Henry Beach, Portland, Ore. Colo., Calif., Wisconsin. Beach member of Silver Shirts, William Dudley Pellay's group in 30's. Violently anti-semitic! "Jesus not a Jew, no holocaust", offshoot of Minute Men in the 60's, Klan, Nazis. Hinckley a member. "Too violent".

Special Agent Larry Knisely. 202 - 324- 3000 D.C. FBI office.

"We are investigating for history".

(Like all the other rotten investigations)

"We will interview anyone who could possibly help understand".

(Another big lie for media use)

"Prosecutors in the U.S. District Court have never seen such a meticulous effort by FBI" (We have heard that every time, more lies.)

"700 agents, 60 FBI offices, 50 FBI on Task Force, 60 offices"

(Numbers on JFK inquiry never found facts)

U.S. Attorney Charles Ruff decision "to personally prosecute JWH." Term expires 1983. They are pushing for quick replacement. Howard Baker, Strom Thurmond, Paul Laxalt, C. Mathias behind this. The old Watergate, CIA, DIA agents. What are they up to? How important is the Hinckley family to try this?
