ITALIAN SCANDAL WILL START TO BREAK OPEN. IT MUST CONNECT TO THE USA, CIA.

Time, 6/22/81

"For 17 days", couldn't be "dissolved."
 "Italians settled in for a prolonged period of political paralysis".
 "Offenses of espionage, tax fraud, illegal currency dealings", etc.
 "An essential preliminary to forming a new Cabinet was to 'shed full light on the P2 affair and TO TAKE ALL NECESSARY MEASURES NEEDED TO DISSOLVE THE LODGE, CENTER OF POLLUTION OF NATIONAL LIFE, SECRET, perverse and corrupting".

In order to do that, must get CIA, NATO, spies,
 US Intelligence out of Italian politics.

"Alessandro Canesi, 84, Italian financier on trial here for illegally transferring funds abroad, yesterday in Milan. (Died).

Time. June 22, 1981

"Col. Luciano Rossi, Treasury Police, shot and killed himself after accusations that he had passed state secrets to Licio Gelli."

"The next day, Minister of Foreign Trade Gaetano Stammati was admitted under an assumed name to a Milan hospital, suffered a 'heart attack'! One report, "suicide". Stammati was questioned about huge payoffs on oil deals with Saudi Arabia."
