"Lee Oswald was encased in cement." "I should find out from strangers that my son is now in a concrete vault".

"The Quest for Truth", George C. Thomson, 1965. Page 44

"This vault is 2700 pounds, almost 1½ tons, reinforced concrete. Why is it this man is buried in such a substantial..I am a design engineer, if we had the job of designing a 2700 pound vault it is normally for a transformer or gas main under ground!"

LIFE, Dec.6, 1963, page 52B

"A 2,700 pound vault was already in place to receive it. That would withstand a sledgehammer", Funeral Director Paul J. Groody reassured newsmen."

(Did the sledgehammer crack the coffin earlier?)

## "NO SCIENTIFIC EVIDENCE OSWALD FIRED THE RIFLE NOV.22,1963"

"House Select Committee on Assassinations", Vol. XI, pages 446-447. Letter from Warren Commission atty. to General Counsel, 8/8/1964. Discovered by Jan Diaz, L.A. researcher.

"It could be set forth by the Commission (Warren) in a frank statement that the Commission has no scientific evidence as opposed to eye witness and circumstantial evidence that Oswald fired the rifle on Nov.22, 1963.

Tape # 359, 10/20/78. "1978 investigation assumed Oswald guilty. No evidence.

Tape # 370, 1/5/79. New Commission didnt prove Oswald received rifle."

1. 3/21/43. Hitler speech, ready to give up. "Nazis go Underground" p6

2. 5/16/43. Berlin meeting, Gestapo, Himmler! "Nazis go under now." p 5-7. Odessa, Spider web conceived. Reiss, "Nazis go Underground."

3. 8/10/44. Meeting of top industrialists. Take "capital out of Germany!" P.23-27. "Martin Bormann, Nazi in Exile". I.G. Farben, invest in 720 corporations, spread around.

4. 10/24/1944 Strategy planned for murder, kidnapping, political coups. Parapolitics, Kevin Coogan. Sindona, Italian, British Fascism.

\$13.5 billion a year. Swiss company. \$19 million order for Swiss survival feed for 3 days, for nuclear attack. Stocking fallouts.

## ORIGIN OF THE GREEN BERETS, GEHLEN, SPY OF CENTURY, E.H. Cookeridge. p.240

"1952, when Ike pres., Gen. Bedell Smith eased out of CIA for Allen Dulles, top Nazis, from Dachau, Eichmann program for extermination, formed our SPECIAL FORCES, GREEN BERETS, for Southeast Asia warm-up. (Discovered by David Emory)

July 26, 1952, Eva Peron died, billions in Swiss banks, in her name. Her death coincided with forming Special Forces death squads. This money used for released Nazi war criminals. John J. McCloy, Warren Commission, Chairman of Chase Manhattan, turned Nazis loose with Peron vaults opened to their operations.
