VIP.KISSINGER AND FRIEND, Maxine Cheshire, 2/1/80. Tape #480.60 minutes, 11/29/81

Sir Y.K.Pao, richest man in the world. Hong Kong. Member of Chase Manhattan Bank's "advisory committee". Chase loans Pao "millions". At Reagan's inauguration with Henry Kissinger, Chase official.

HONG KONG and NUGAN HAND BANK, CIA, NARCOTICS

Neil Evans, Nugan Hand rep. in Thailand, "Michael Hand announced, 1977, meeting of bank leaders, Hong Kong, Nugan Hand just got the CIA's account, would be laundering millions for the Agency". 2/18/81

Henry Kissinger used Nugan Hand, 1972-73, to kill Allende, overthrow the governments in Chile, Australia, put his Nazi pals into office.

CHARLES TEX THORNTON, LITTON INDUSTRIES, DIED. 11/26/81

Texas, U.S. Army, Ford Motor Co., Hughes Aircraft, Litton Industries. Litton used as conduit for CIA to put Nazis into Greek Government. Death of Democracy, Stephen Rousseas, Grove Press, N.Y. 1967. Dedicated to Andreas Papandreou, now Prime Minister of Greece.

"THE JACKAL REPORTEDLY AT WORK IN SYRIA" UPI, 11/16/81

George Korkola, Frank Terpil kidnapped Nov.9, 1981, in Lebanon by "three men from Syria". Was Charles doing his CIA job to wipe them out? Worked with Edwin Wilson, S. Commings, Korkola, Terpil. "Helped Libya with several assassinations".
