Justice Dept, OPERATION GATEWAY, working with FBI, DEA, U.S. Customs, Treasury, Internal Revenue, Federal Aviation Administration.

Came across links of CIA, Frank Terpil, Edwin Wilson, Bradley Bryan, with CIA, Nugan Hand Bank, Australia, gun running, narcotic traffic, illegal Vegas skimming money, COMPANY, deaths related to bank family members.

"40 indictments coming soon". (I doubt that)

Aug. 6, 1978, Sante Allesandro Bario, made Justice, FBI connections.

Sept. 1978, San Antonio, Texas, Bario arrested. He was high level investigator.

Dec. 16, 1978, Bario poisoned, John Bolushi peanut butter, strychnine.

Sept. 15, 1978, CIA John Hart, testifying, House Select Comm. on JFK assass.

(Navy Intelligence, mob, gun runners, narcotic, CIA)

Sept. 23, 1978, one week later, CIA, John Paisley, Nugan Hand, Oswald, dead.

May 29, 1979, Judge Wood, Texas murdered. To convict Jimmy Chagra, Nugan Hand.

Jan. 27, 1980, Frank Nugan murdered. Now linked to Vegas, CIA, Company
