5/13/82 arrest of Turkish national, provided gun for Agca. Omer Bagci. Right wing "Turk Ocakiari". Plot behind attack.

## "REAGAN PAL SUED FOR 'PALIMONY' 7/4/82 UPI, SFC.

Alfred Bloomingdale, Vici Morgan. Agent for FRANK SINATRA, early days. \$18,000 a month, "lifetime support".

12 year relationship, 12 year old son. Traveling companion. "Business partner" SHOW BIZ PIZZA; pizza enterprise.

"Money came until 3 weeks ago. July 1, no check." SJM 7/9/82  
"He was at her place every day, they traveled together".

## "EDWIN WILSON WANTS LOWER BAIL"; 7/10/82 SFC. Lured via Dominican Republic.

"Assisted USA, Rome, 1981, with U.S. assist. atty. E. Lawrence Barcella. July 7, 1981, five weeks after Pope shot. Agca, Terpil, Wilson links.

## "TENTACLES OF INTERNATIONAL SCANDAL REACH INTO REAGAN ADMINISTRATION"

Spotlight, 7/12/82

Edwin Wilson, Erich von Marbod, Richard Perle, Edward Luttwak, Richard Pipes, Thomas Clines. CIA, Defense Dept. links. Mossad?

Tries to make Israel connections. Leaves out Georgetown Nazis, Sadat murder, PLO, CIA, Bush.

## PAN-AM EXPLOSION, NEW ORLEANS, July 9, 1982. 143 on Plane.

NBC -TV, 7/11/82 "We may not know the cause for six months". Cautious this time. Plane must have been carrying explosives. Frankfurt, Montevideo, Uruguay, Hong Kong, Australia, Switzerland, Brazil, Australia, Yugoslavia. All going to Vegas except 10.

## JOHN BELUSHI AND THE LOS ANGELES POLICE GESTAPO, MURDER INC.

Herald Examiner, 7/8/82. "Belushi a horrible person, not much of a man, there are many other important crimes to solve. He died vomiting in the toilet and lay on some bed nude and that to me, that's a disgusting way to die". LAPD Chief Daryl Gates.

Cathy Smith, earlier drug charges dropped, probations. Herald 7/8/82. Robert de Niro, with Belushi hours before he died, hired Paul Rae Jr. for advice on a movie, Paul represented Vito Genovese (Secy of Labor Raymond Donovan connections), Johnny Dio, Jimmy Hoffa (George Shultz, R. Donovan, Haig, Kissinger contacts), and Mickey Cohen. Criminal lawyer. SFC 7/11/82 Starred in Taxi with Jody Foster, Hinckley mind control object.

## LAPD TO PAY \$25,000 in ALLEGED TERROR CAMPAIGN, LAT 6/82.

Damages to architect, police intelligence, 5 year harrassment. "Fascist, terrorist" activities. slashed tires, bricks thrown at him. Threatened to murder, surveillance 2 years, protest march in N.C. Guns to his head. Too left politically. Public Disorder Intelligence.

## WILL ARCHBISHOP PAUL MARCINKUS BE FORCED TO LEAVE THE VATICAN?

"Pope Asked to Fire Vatican's Top Banker", S.F. EX. 7/8/82  
President of Vatican bank since 1971, founded 1942.  
Dealings with Banco Ambrosioni, Roberto Calvi was president.  
Marcinkus signed letter of patronage to Calvi for the loans,  
\$1.4 billion, releasing Vatican bank from all but \$250,000,000.

Marcinkus resigns from Nassau, BAHAMAS, subsidiary.

"The crises hinges on the Vatican's refusal to assume responsibility  
for guarantees of about \$1.27 million lent to Latin American subsidiaries"  
UPI, S.F. Ex. 7/7/82 Peru, Luxemburg, Nicaragua.

Early Nixon, fee of \$1,625,000, family of Dominican President  
Rafael Trujillo, after their father killed by CIA.
