 No criminals here, just politically concerned.

Files went into Western Goals, Va. Based (Germany also), "right wing non-
 profit foundation attempting to create a data base for Internal
Security information" Linda Catoe Guell, John Rees, Oct. 4-5, grand jury.

9/14/83, LAT "Judge OKs Subpoena for Police Spy Case.

Rep. Larry McDonald, \$100,000 computer, LAPD files, Western Goals.

Guell an important witness, directed Rees to get LAPD Jay Paul files.

LAT 1/19/83

1970 Public Disorder Intelligence Division, Chief Ed Davis, PDID formed.

1972 Louis Tackwood, E.H. Hunt, White House Plumbers, Kissinger, CIA, DIA.

1975 2,000,000 intelligence files ORDERED DESTROYED. End of Vietnam.

1977 Police agent exposed, dirty tricks still going on, murders, etc.

1978 Coalition Against Police Abuse formed.

1981 Undercover agents still at work, spying on private citizens.

1982 Discovered documents channeled up chain of command, LAPD chief D.
 Gates lied, misled on spying issue. Admits files exist, illegally
 removed from Police offices.

1/7/83 Files discovered, Long Beach, 50 boxes, PDID Jay Paul, wife Mary Love.

5/24/83 Larry McDonald, John Birch, Western Goals, paid \$100,000 for computer
 to send names, records of Va. Military, Mafia, CIA, DIA, FBI recipients.
