## CONGRESSIONAL RECORD, REP. HENRY GONZALEZ, Sept. 15, 1983

"Kissinger's Commission, Central America, to quiet dissent; Gonzalez  
"Wants no dialogue, debate on foreign policy. This is to silence Congress."  
"We cant have "foreign policy debate like 10 years ago; Kissinger.  
"Kissinger's role to rationalize existing policy"  
"He tries to make everything appear partisan, goal is suspect, dishonorable. Job of throwing blanket over Central America."

Kissinger and Associates, with Lord Carrington, promoting his own funds. Kissinger runs State Dept, "has his own State Dept."

Kissinger "is not only advisor, he is a hired gun".

"He lied in 1973, about Paris Agreements". H. Gonzalez.

"Now in position of higher visibility. Appointed to his commission Harry Slatterman, former Amb. Argentina, CIA station chief in Chile, for destruction of Allende regime".

"Has access to everybody in USA, believes nobody but HK can solve riddle of Central America".

"Tries to boost visibility, he is a State Dept. of his own, for sale, rent."

Resolution, investigate Kissinger and Associates. Payments to Kissinger.

"People who hire Kissinger have great stakes tied up, status quo, dont care about poverty, hunger, frustrating democratic processes, killing reform, investments to protect, pay for his advice"

"Under the pay of Chase Manhattan, charges 1/2 million fee to consult".
