Ready to become Secretary of State, possibly president.

3. January 23, 1984 REBEL Don Freed, Alfred Bloomingdale's spy for Ronald Reagan. EDWIN MEESE NAMED HERE. Mafia links, assass. teams.
4. Jan. 9, SJM ACLU needs funds, 5 year suit about to begin. 131 plaintiffs, individuals, organizations, law abiding, vs LAPD.
5. Jan. 11, LAT. Supreme Court appeal for ACLU to identify Police Spy.
6. Jan. 11, LAT "NEW EFFORTS TO END TRIAL, SETTLE OUT OF COURT" ACLU wants watchdog on LAPD Anti-Terrorist Unit. Hoped if settled out of court, would get necessary restrictions.
7. Jan. 14, L.A. Her. Mayor Tom Bradley pushing for out of court deal. Former LAPD himself, ~~doesn't~~ want open testimony. LAPD Chief Darrell Gates, former Marine officer, objects STRENUOUSLY to watchdog.
8. Jan. 15 SJM "Police spying case is settled" City Council INFURIATED, meeting deals leaked.
9. Jan. 15 L.A. Her. CITY COUNCIL SAYS "MOST OF POLICE OFFICERS ACCUSED OF ILLEGAL SPYING ARE INNOCENT". No court, Judge, just an announcement.
  1. Kept illegal papers, ordered destroyed in 1975, today.
  2. Took them home, fed to computers to Pentagon, Germany, Austria.
  3. Illegal to take home, Given to Birch Society, Murder, Inc. Va. Ga. The IDENTICAL MURDER, INC. JACK ANDERSON IS WRITING ABOUT.
10. Jan. 16 L.A. Her. "The Council tentatively agreed to announce that the majority of police are innocent of wrongdoing" Repeat. "The City Council is concerned the plaintiffs, 131, will reject their offer, because it might strengthen ACLU'S resolve TO PROVE OFFICERS ARE GUILTY."
11. Willard Carr, SPOKESMAN FOR GIBSON, DUNN AND CRUTCHER.

12. Jan. 18, L.A. Her. New secrecy proposal, punishment if meetings leaked.
13. Jan. 19, Los Angeles Police Commission refuses to question, be involved with Anti-Terrorist unit". The trial would cost millions and distract police at time of OLYMPIC GAMES.
14. Jan. 19, Wednesday. RONALD REAGAN, WILLIAM FRENCH SMITH, AGREE HE SHOULD GET TO CALIFORNIA. HELPING REAGAN'S CAMPAIGN=STOP ACLU SUIT.
