FEB. 29, 1972, JOURNALIST JACK ANDERSON PUBLISHED THE "DITTA BEARD"  
MEMO, WHICH SUGGESTED THE GOVERNMENT WOULD DROP AN ANTITRUST LAWSUIT AGAINST  
ITT IN EXCHANGE FOR A \$400,000 DONATION TO THE REPUBLICAN NATIONAL  
CONVENTION.

Contribution scandal caused GOP convention to be moved from San  
Diego to Miami, Fla.

Sudden move didn't allow enough funds for GOP riots like Chicago, 1968,  
or money for possible Nixon murder teams..

Identified donors to GOP after April deadline would be linked to the  
provocateurs, violence, so violence called off. Nixon removed by tapes.  
Vicar Alex. Haig, Nelson Rockefeller, Warren Commission Jerry Ford still  
moved into control of White House with H. Kissinger.

"USIA COUNSEL DESTROYED FILES TYING DIRECTOR CHARLES ZWICK AIDES TO  
BLACKLIST" SFC 12/27/84

Faced with inquiries, USIA LEGAL ADVISER THOMAS E. HARVEY, JOHN MOSHER,  
AND ACTING DEP. DIRECTOR LESLIE LENKOWSKY DESTROYED 135 DOCUMENTS.

Watergate: Shredded, "deep-sixed", erased tapes, destroyed evidence.  
Acting Director of FBI Patrick L. Gray, C. Colson, J. McCord, etc.

"INMATE KILLED IN PLUNGE" HIT MAN SUSPECT DIES IN ESCAPE TRY, N.Y. PRISON"  
Houston Post, 2/21/84

William Arico, 47, hit man for God's Banker, Vatican, Michele Sindona  
Fell to death, 9th floor, Federal prison, NY Lower Manhattan.  
"cut bars, made rope of sheets". FROM NINTH FLOOR? How many sheets?  
Justice was to extradite Arico and Sindona to Italy, accused of 1979  
murder of Giorgio Ambrosoli, lawyer, liquidating Sindona's bank collapse.  
Tapes # 414, 426 on Ambrosoli murder. ONE MORE WITNESS.

NASA PICKS LOCATION FOR SPACE STATION WORK , SFC, 2/16/84

Marshall Space Center, Houston, won over Marshall Space Flight  
Center, Huntsville, ALA. Huntsville Nazi enclave, Von Braun Germans.

RICHARD B.STONE REPLACED BY HARRY SHLAUDEMANN as special envoy to Central America. MH 2/18/84

"U.S.LATIN ENVOY QUILTS IN PROTEST" ,SFC 2/17/84

Richard B.Stone was appointed last April to demonstrate the Reagan administration's willingness to seek negotiations for peace in Central America". He was "diffuse charges the administration was ignoring the possibilities for negotiations in the area".

WITH THE APPOINTMENT OF SHLAUDEMANN,KISSINGER'S executive director of the National Bipartisan Commission on Central America,only deaths,blood bath can follow.Tape # 634

3. "Jonestown Survivor kills 1,wounds 13,shoots self".L.A.Her.2/25/84  
Tyrone Mitchell testified before a federal grand jury investigation on the assassination of Rep.Leo Ryan before.Now opening again.  
Known to LAPD as armed,many weapons,on drugs,located directly across from 49th St.Elementary School. Had 180 rounds ammunition.  
Trained assassin,combat clothes,army weapons,arsenal of bullets. Known to police at nearby station.Recent complaint filed. Military combat assault rifles, AR-15. Double-barreled shot-guns. Dozens of live shotgun shells.Wore army boots,shirt,pants.  
LAPD in contact with Mitchell's Jonestown atty.in San Francisco, MARCUS TOPEL,DURING THE SEIGE.  
Identical to SLA, LAPD in touch with Donald DeFreeze until one hour before their SWAT TEAMS killed all six ,set on fire.
- 4.DR.HARDAT SUKHDEO,worked with 100 or more survivors of Jonestown, is PROFESSOR OF PSYCHIATRY ,UNIVERSITY OF NEW JERSEY MEDICAL SCHOOL, NEWARK. SFC 2 / 25/84
- 5.Lowel Streiker,Director of Freedom Counseling Center,Burlingame, Calif,"counseled people from Jonestown who had been SPECIFICALLY PROGRAMMED TO KILL". SFC 2/25/84
6. Tyrone Mitchell with CIA attorney John Blatchford,and 17 defectors when arrived in USA. Tape # 373
