Joseph Paul Franklin:

Aquitted in 1980 shooting of Vernon E. Jordan, Natl. Urban League president.
Indicted for synagogue bombing July 29, 1977, Chattanooga, Tenn.
Suspect in at least 13 homicides in seven states 1977 - 1980.
Suspect for attack in 1978 of publisher Larry Flynt
Madison, Wisc. slaying of Alphonse Manning Jr. and Toni Schwenn, interracial.
Serving life sentence for Aug. 1980 slaying of two black youths, Salt Lake, Utah.
"The purpose of the synagogue blast was to kill Jews".
Franklin a member of Ku Klux Klan and American Nazi Party.
Arrest in 1975, assault and battery charges, sprayed chemical Mace on interracial.
Trial never held.
March 1977 arrest for illegal possession of a pistol. 10 days in jail, \$500 fine.
Aquitted of shooting Vernon Jordan in Fort Wayne, Indiana.
Why is he confessing to Flynt shooting? "To escape in Georgia, better chance".
