EDWIN MEESE nominated to become Attorney General. "ALAMEDA COUNTY MAFIA"  
1959 - 1967, deputy district attorney, Alameda. Left to join Gov. Reagan legal secy.  
D. LOWELL JENSEN, Meese's deputy District Attorney, then district atty. Alameda County.  
JENSEN CAME TO DC, appointed assist. atty. gen, Criminal Division. Now promoted, #2 Justice.  
ALAN C. NELSON, was deputy district atty., Alameda, 1964-1969.  
Now commissioner of Immigration and Naturalization Service, Justice Dept.  
LOIS H. HERRINGTON, former deputy district attorney, Alameda, now director of Office of Justice Assistance, Research and Statistics. Chairman of Reagan's Task Force on Victims of Crime.  
ROGER OLSON, deputy district atty. in Alameda County, 1969-1972. Knew Meese, law clerk.  
Moved to DC in 1981, to become deputy to JENSEN in Criminal Division.  
Now deputy assistant atty. gen. in Tax Division.  
WILLIAM R. MCGUINNESS, worked as deputy district atty, Alameda. now deputy to Jensen.  
JAMES K. STEWART, deputy chief of police, Oakland, now director of National Institute of Justice.  
CHIEF JUSTICE EARL WARREN, once served as district attorney, Alameda County before running as Vice-President with NY Gov. Tom Dewel. (Lucky Luciano, OSS, release)  
Alameda with LAPD, Calif. Intelligence, prison riots, Black Panthers, Isla Vista, California violence, provocations, Operation Chaos, FBI COINTEL-PRO.

1. "NO COVER UP VOWED AS MEESE PANEL SCHEDULES EXTENSIVE NEW INQUIRY" LAT 3/16/84

At least 8 new witnesses to be called:

Edwin Thomas, General Services Administration, Regional administrator.  
 Loan, Ursula Meese \$16,000, no interest, not declared to judiciary, Senate.

Dr. Earl W. Brian, BIOTECH, NY. \$16,000 went to Biotech, Brian long friend  
 of Reagan, Calif. Health, Education and Welfare.

Ted Elkin, real estate, put up \$70,000, covered by Thomas J. Barrack.

General William Berkman, Chief of Army Reserve.

Joseph Sullivan Jr, figured in Neese's Reserve transfer, promotion to Col.

Army Inspector General who said "promotion should not have occurred".

James Schmitt, Loan Officer, Great American Federal Savings, San Diego,  
 allowed Meese to fall back 15 mos. in payment.

MONEY WENT TO BIOTECH, HEADED BY DR. EARL BRIAN.

MEESE GETTING NOTES FROM ROGER STONE, bagman, paid informant, 1972, against  
 McGovern. Age 19, political intelligence. Watergate to Cartergate.

2. "HOW SAVINGS AND LONAS HAVE A FRIEND IN REAGAN REGIME", WSJ, SFC 11/18/80

Gordon Luce, San Diego Federal Savings and Loan, close advisor to Reagan,  
 provided controversial loans for Edwin Meese III.

3. APPOINTMENTS EDWIN MEESE III, RONALD REAGAN MADE FOR FRIENDS OF MEESE, MONEY, MILITARY JOB.  
 AFC 3/19/84

1. ED GRAY, San Diego Savings and Loan, appointed Federal Home Loan Bank Board.

2. GORDON LUCE, San Diego Savings and Loan, appointed US Mission to United Nations.  
 Meese behind 34 mos. payments.

3. THOMAS BARRACK,  
 Calif. developer, middle man between Meese and Elkin, Reagan pal, who put  
 \$70,000 to sale of Meese home. Two weeks later, he was in DC, became  
 appointed to assistant secretary of INTERIOR, James Watt. Meese, Vice-Pres. of  
 Rohr Industries, dumping chemicals in Riverside, political delay to clean.

4. JOHN MCKEAN, arranged \$80,000 loan. Offered U.S. Postal Service Board of Governors  
 one month later.

5. EDWIN THOMAS, arranged Ursula Meese's \$16,000 stock. Became Calif. head of  
 General Services Administration.

6. MAJ. GENERAL THOMAS K. TURNAGE worked on Meese's quick promotion as ARMY Col. Reserves.  
 July 2, 1981, Reagan announced Turnage to be director of Selective Service.

7. "GRETCH" THOMAS, wife of EDWIN, LOAN OF \$16,000 to Ursula Meese.

Named by Reagan as an attorney examiner, presiding official, MERIT SYSTEMS  
 PROTECTION BOARD, S.F. (L.A. Herald 3/18/84)

8. HERBERT E. ELLINGWOOD, Meese long time associate, who hired Gretchen Thomas,  
 wife of Meese loan never declared, named Chairman of U.S Merit Systems  
 Protection Board where Mrs. Thomas joined him without public hearings.

4. "URSULA MEESE AND AMERICAN CYTO-GENETICS" LAT 3/18/84

In addition to BIOTECH, Ms. Meese had stock in AMERICAN CYTO-GENETICS"  
 a subsidiary of BIOTECH.
