Photograph of Kissinger's Fritz Kraemer came from Pentagon, 2/27/70 award. NBC, all media, pushing "Bulgarian-KGB" link to shooting of Pope John Paul II. Murder of Lt. Col B. Nut, French chief of espionage, 3/13.83. FBI documents to deport John Lennon, Jon Wiener, history professor.

"MEHMET ALI AGCA, 53 page indictment, charged by military court in Istanbul for murdering Abdi Ipek, editor, Feb. 1979". Houston Post, 1/29/84

Pope John Paul II's assailant was part of smuggling racket before 1979 arrest. Escape from Turkey arranged after Ipek murdered. Kept narcotic smuggling.

"MADALYN MURRAY O'HAIR, RELATIONSHIP TO LEE HARVEY OSWALD AND FAMILY" KANSAS CITY, 3/84 Bill Murray lecturing on mother and Oswald family.

"ATHEIST TO HELP FLYNT", 3/84 "Mrs. O'Hair given power of attorney to control Flynt's corporate and personal assets until he is out of jail".

MITCHELL LIVINGSTON JOHN WerBell III, Eagle, June 1984 .Security Council to Larry Flynt"

"Adviser to kings, premiers, presidents of corporations, CIA operatives, 'THE GENERAL', "anyone that's on a hit list and wants me to help, I will".

(Even somebody who has Vicki Morgan and Edwin Meese sex party tape)

GORDON NOVEL, Bob Cutler, Grassy Knoll Gazette, Dec. 1979

Novel with CIA, David Ferrie, Guy Bannister, on NBC payroll with Walter Sheridan. Lived in Ga., New Orleans. 1978 sent to Federal Correctional Institution, Butner, North Carolina. Received guns from Mitchell WerBell III, both CIA.

REALIST, Aug. 1973, Mae Brussell, "Martial Law without the riots".

Dismantle UCLA Institute to Study Causes of Violent Behavior, U.S. Medical Center for Federal Prisoners in Springfield, Mo. (where Larry Flynt was sent), and Behavior Research Center, Butner, North Carolina where Clockwork Orange is alive and well in the USA". where Larry Flynt is now.

55 appointments ensnared in ethically questionable or illegal business before or during government service. Research by House subcommittee.

At least 24 resigned or fired, one convicted, others criticized or censured. Walter Mondale calls it "the sleaze factor in the administration. Mae Brussell calls it Nancy and Ronald's idea of "high society".

"MEESE'S TIED TO SLOT DEAL, WIFE TIED TO ILLEGAL VEGAS SLOT DEAL", March 24, 1984 S.F. Ex.

Questech Capital Corp. was winning \$5 million federally backed financing, at same time wife of Edwin Meese's wife buying stock, and they are illegally investing \$100,000 in Las Vegas slot machines".

"Questech one of NUMEROUS Biotech subsidiaries. What are the others?"

"The gambling investment was made in the form of a loan to a Las Vegas company, NOT NAMED, owned by a second firm. (NOT NAMED) The parent company then loaned the money to a third firm (NOT NAMED) which used it to buy yet TWO OTHER COMPANIES, (NOT NAMED) which owned 600 and 200 slot machines."

(How about identifying all these Las Vegas firms, originating with Dr. Stuart Brian, and Calif. former Medicaid chief. HEW and Medicare and what else?)

Dr. ^{Carl} Stuart Brian, head of Health, Education and Welfare under Reagan's governorship, was also with Edwin Meese to serve on CALIFORNIA COUNCIL OF CRIMINAL JUSTICE. NYT 3/16
