Edwin Thomas put \$50,000 to \$100,000 into Biotech, friend Dr. Earl Brian.
Ursula Meese invested in this firm, BIOMEDICS. Brian long friend, with Thomas family.
BIOETECH bought nearly 1/3 of ASSOCIATED BIOMEDIC SYSTEMS, INC. Buffalo, NY.
Failed to meet Food and Drug Administration requirements .
Private contract to produce INTERFERON .
The company won a contract with Health and Human Resources, Nov. 1981.
They were to provide samples of blood to the NATIONAL CANCER INSTITUTE.
They failed FDS standards, "but THIS WAS NOT THE REASON FOR BANKRUPTCY"

Sold April 29, 1983, three times investment. Next day, stock took giant drop.
