Part II of the LAPD Saga.LAPD settled out of court, \$1.8 million to ACLU,illegal spying,Police Intelligence,on law abiding citizens.

52 organizations,individuals,vs.WESTERN GOALS. #599, 5/30/84 List of Board.
Violation of rights,putting information into Jay Paul,John Rees computers.
Joan Baez,Bonnie Raitt,Jackson Browne,Mike Farrell (producer),Norman Lear,
Stanley Scheinbaum (Regent of U.C).

Court injunction ordered to "dont destroy" information.
LAPD Jay Paul had computer terminal in wife's law office,Mary Love,Long Beach.
Information went not only to JOHN RYAN,EMPLOYEE OF WESTERN GOALS,
BUT TO THE HOME OF JOHN REES. (This is the Edwin Meese,Jerry Ducote,Reagan gang)

EDWIN MEESE AND THE ACLU,HE MUST BE BOILING NOW.NOT CONFIRMED ATTORNEY GENERAL.

1.New Yorker, 7/20/81 Meese,"The ACLU is opposed to law enforcement,it is a Criminal Lobby". He wanted a "law abiding citizens group ,free from criminal Activity of ACLU". 1984,LAPD settled because THEY WERE THE CRIMINALS.

2.SFC 5/11/81 "Meese cited ACLU and Prisoners Union as two groups that "have formed a lobby which is opposed to law enforcement".Reagan will "appoint tough law-and-order judges,federal law enforcement officials." (Who would loan \$\$ to Meese).
