John Loftus, Boston, blames USA more than Vatican. Use of Nazis, escape routes.

- 1981 Ann Yarbrough and James,\$74,000 "loan"never paid back,COMMERCIAL BANK OF CALIF. Deal with others to buy Reagan home fell through,9 charges dropped.
- Jan.1981,Ursula Meese,\$15,000,Dr.Earl Brian.Might cost Meese Atty.Gen.appointmen

- 1982 Timothy Hoffman told DEA,FBI about DeLorean,Johnny Carson drug allegations. COMMERCIAL BANK now has \$2.5 million,"bad loans",in trouble. Hetrick,Durand,Hoffman,ready to "get DeLorean",save their freedom,money. ARNOLD KOPELSON and MICHAEL MILLER TAKE OVER COMMERCIAL BANK FROM CARSON,BUSHKI Kopelson former law partner of Bushkin.June,1982,David Allan Saxon afraid of his life.Saxon,Kopelson,2 bank officials,THREATENED TO BE KILLED IF TALK OF COMMERCIAL BANK'S PAST,SORDID CONNECTIONS.
