RICHARD NIXON LEFT WHITE HOUSE AUGUST 8, 1974      ESCAPED WATERGATE IMPEACHMENT TRIAL.

- A. JAMES McCORD, ATTORNEY BERNARD FENSTERWALD, made the first break in the case. CIA GERALD FORD, from WARREN COMMISSION, NELSON ROCKEFELLER, DeMohrenschildt, Oswald took over White House.
- B. ALEXANDER BUTTERFIELD, ALEXANDER HAIG, made second break, WHITE HOUSE TAPES.  
"Years of Upheaval", Henry Kissinger, Little Brown, 1982, White House years.  
"Haig would replace Haldeman". "An old mentor, FRITZ KRAEMER, came up with the name of ALEXANDER M. HAIG, JR." Haig brought Butterfield from Australia to W.H.

He was seeking another term this fall without Republican opposition. (See who wins)

FRENCH RESISTANCE HERO, FIGHTER, JUST BEFORE KLAUS BARBIE TRIAL TO TAKE PLACE IN FRANCE.

GILBERT RENAULT, 79 yrs. "Apparent heart attack" . NYT 7/30/84

Anniversary reunion with Resistance fighters.

"Remy" his pseudonym, "MEMOIRS OF A SECRET AGENT OF FREE FRANCE," 1948

Failed to show up for breakfast, body found by hotel employees.

COL. EDWARD GLAVIN, 81. AIDED IN THE SURRENDER IN ITALY. NYT 7/29/84

Helped with secret surrender of 1,000,000 Nazi troops May 2, 1945. SERVED OSS.

Degree from BALLIOL COLLEGE, OXFORD, military attache U.S. Embassy in London.

Director of Army's education programs, U.S. headquarters in Frankfurt, Germany,

where HE HAD THE GOAL OF EDUCATING US TROOPS AND "MAKING THEM AWARE THAT THE

WAR WAS OVER AND THAT "HATE GERMANS" ATTITUDES OR PERSONAL REPRISAL AGAINST

GERMANS WERE NO LONGER TOLERATED"

SS Karl Wolff, liason between SS Gestapo Heinrich Himmler and Adolf Hitler, was running Treblinka concentration camp WHILE WORKING WITH ALLEN DULLES AND COL. E. GLAVIN.

When camps discovered, extent of murders, tortures revealed, those on the SPOT, HAD TO BE TOLD "DON'T HATE GERMANS". Director Alfred Hitchcock, consumed with death, horror films, suppressed for 39 yrs scenes of camps.

1956, retired, went to work for New York University, fund-raising.

Norman Redlich, Warren Commission Counsel, chief of NY Law School.

State Senator Larry Kuriyama. Arthur K. Baker. Robert Fukumoto and CHARLES MARSHLAND III, 19 year old son of Honolulu prosecutor Atty. Charles F. MARSLAND.

DOCTOR'S POSTMORTEM , Wash. Post, 7/23/84 "THE POLITICAL MEDDLING IN CORONER'S OFFICE".  
DR. DOUGLAS S. DIXON QUILTS HIS JOB

Three of six positions vacant. Fifth D.C. medical examiner to leave in the last 18 mos. Dixon, could no longer work for an office where "POLITICAL CONSIDERATIONS influence the medical examiner's findings".

Forced to do autopsy not warranted. Forced to rule suicide "accident".

"Pressured to forgo autopsy on RABBI FOUND MURDERED IN HIS HOME". There was a "time in that day when the Rabbi was murdered, when I was prepared to take off my gloves and walk out, resigning not only as acting chief but as deputy medical examiner as well, in protest over what I consider to be AN EXTREMELY DANGEROUS MEDDLING" Rabbi's murder never solved.
