# Co-Defendant of DeLorean Awaits Sentence

While John Z. DeLorean is a free man, his original co-defendant in the \$24-million cocaine-trafficking case remains behind bars, awaiting sentencing on the drug conspiracy charges to which he pleaded guilty.

William Morgan Hetrick, 53, a pilot and one-time operator of a Mojave air service, is being held in an undisclosed location because he agreed in a plea bargain to be a government witness.

There was some expectation that Hetrick, whose meetings with DeLorean during the federal "sting" operation were secretly recorded, would be a government witness against the former auto maker. In entering his guilty pleas on June 13, 1983, Hetrick agreed to testify against DeLorean if asked to do so.

However, he was never called to the stand.

Stephen Wilson, Hetrick's attorney, said Friday that he had not spoken to his client since the DeLorean acquittal and did not know his reaction. He said that based on his last contact, Hetrick is "doing as well as can be expected in uncomfortable conditions. His family is going through difficult times."

## Pleaded Guilty

Wilson said he expected Hetrick to be sentenced within 60 days. Hetrick, described by federal investigators at the time of his arrest as one of the busiest drug smugglers in Southern California, pleaded guilty to six counts, including conspiracy to possess and distribute cocaine, income tax evasion and unlawful transportation of currency outside the United States.

The maximum possible sentence on these counts is 49 years in prison and fines up to \$600,000.

As part of the plea-bargain agreement, Hetrick pledged to take part in a "debriefing" about his smuggling activities. He also agreed to government seizure of his Mojave aviation service, four boats, five airplanes, 12 cars, accounts in seven Southern California banks and \$448,931 deposited in a Cayman Islands bank. In return, the government promised not to prosecute Hetrick's sons, Buzz and Jinx Hetrick, or his stepson, James Coward.

Hetrick has been in custody since his arrest in October, 1982.

Another member of the drug-smuggling scheme, Stephen Arrington, 35, pleaded guilty to charges of conspiracy to possess and distribute cocaine, and of distributing 25 kilograms of the drug, which was found in his car on Oct. 18, 1982.

Agents used that cocaine the next day as a product sample to present to DeLorean in the now familiar videotaped scene in which DeLorean was arrested and handcuffed.

Arrington is now serving a five-year sentence in the federal prison in Boron, Calif.
