London Observer, 9/25/83, Ronald Reagan's comments on Korean Airline 007, "the administration thought the impact would blow over in 2-3 weeks".

WHY RAYMOND DONOVAN APPOINTMENT, INVESTIGATIONS, AND INDICTMENT IS IMPORTANT. EVIDENCE HOW THE MAFIA, ORGANIZED CRIME HAS TAKEN OVER WASHINGTON, D.C AND WHITE HOUSE.

1. Secy. of Labor Raymond Donovan first cabinet member indicted while in office. Reagan went through with nomination and continued support with full knowledge of current charges and connections before his inauguration, Jan. 1981.
2. GOP's dept to MAFIA, CRIME SYNDICATE goes back to Tom Dewey, Earl Warren, Lucky Luciano. THE MAFIA MADE RICHARD NIXON AND RONALD REAGAN. They help wipe out witnesses to their usurped power, via phony elections and assassinations. Frank Sinatra, Paul Laxalt the overview. Schiavone contracts, Donovan another view.

3. Raymond Donovan, Schiavone Construction witnesses, tangled in complicated web of events from June 3 through July, 1983. Reagan, Pope John Paul II, Roberto Calvi murder, Edwin Wilson brought home, lots of deaths, changes in Mafia, White House.
4. Unfinished business of Nov. 22, 1963, covered again by Watergate, still surfacing with same White House staff, attorneys. A continuity of pay-offs, death threats. Genovese family, Jack Ruby, New Orleans, Carlos Marcello, Vatican and Permindex.
5. The Donovan confirmation process for a cabinet appointment illustrates how the Senate, Congress are treated as fourth rate natives, 3rd world. Information held back.
6. The FBI is part of the crime syndicate, in bed with Mafia and Nazis since J.E. Hoover. FBI Director William Webster SHOULD BE FIRED TODAY based upon DONOVAN SCANDALS THEY COVERED UP, KEPT FROM CONGRESS, KEPT FROM INVESTIGATIONS, KEPT FROM USA CITIZENS.
7. Minority program scandals, a clear view via Donovan JOPEL contracts, used as dummy front for skimming profits, token black used. How Blacks, Puerto Ricans, etc. cant get jobs. Perversion of intent in DC, campaign promises. Coaxed to go for \$2.50 hour or nothing.
8. Infiltration of Congressional staff members best understood through Donovan-Ronald Schiavone. Death threats, bugging, informing those being investigated. Justification, "clear innocent". Two years later, R. Schiavone, R. Donovan indicted.
9. Death squads exist in USA, identical to Chile, Argentina, El Salvador, Nicaragua Contras, and other dictatorships. Primary witnesses to Donovan, Schiavone killed. Threats.
10. The Federal Government cant be responsible for honest investigation or prosecution of persons working for, or with the White House, Congress, govt. agencies. When the Attorney General is the President's best friend, even his brother, guilty get off. Only a local D.A., such as in the Bronx, N.Y., could indict Donovan and 9 defendants.

CHRONOLOGY OF DONOVAN INVESTIGATION

- 1952 Donovan graduated Notre Dame Seminary, New Orleans, La. (Cardinal Cody, C. Marcello)
 - 1957 Meeting of Mafia, Italy, USA, to decide territory and distribution activities. Close links to Richard Nixon, Ronald Reagan. Vatican, P-2, M. Sindona, L. Gelli.
 - 1959 Donovan joined Schiavone Construction, New Jersey, assets \$20,000. Grew to \$500 Mil.
 - 1976 Jo-Pel, JOPEL construction formed, NY. Contractor to Schiavone, Donovan Vice-President. Sen. J. Galiber, NY, token black for minority funds that were to come in. William Masselli, Genovese family. Phillip Buono partners.
 - 1977-1981, William Orlando FBI informer. Broke Donovan story to DA in 1983. Told FBI about Donovan, mobsters Jan. 8, 1981, before confirmation hearings. Fiascone murder.
 - 1978 William Orlando, William Masselli killed Salvatore Fiascone, brother-in-law and business partner of Louis Nargi, competitor with Masselli for Schiavone contracts. Orlando working for FBI when murdered Fiascone.
 - 1979 Raymond Donovan signed \$200,000 check to William Masselli, "started his business, contract with JOPEL for \$169,000,000 FEDERAL FUNDS, SUBWAY, EAST RIVER, NY. Masselli in meat packing business, butcher, Bronx. JOPEL TO CONCEAL MINORITY AGREEMENTS, STIPULATIONS FOR HIRING. \$8,000,000 skim now charged by D.A.
- Jan. 4, 1979, FBI wiretaps put on William Masselli, meat market, Bronx. 892 tapes. One year BEFORE REAGAN ELECTED, DONOVAN ON CABINET, FBI HAD THIS INFORMATION.
1. Talks about how they murdered Salvatore Fiascone.
 2. William Donovan's name mentioned "AT LEAST SIX TIMES". Didn't give numbers.
 3. Democratic officials in NY, Albany.
 4. JOPEL AND SCHIAVONE partnership in construction contract, subway schemes.
