ABC SOLD QUICKLY TO CAPITAL CITIES.

1. NYT 3/19/85 "Little known Media Co. in Surprise Takeover for ABC."
Front page story, no mention of CIA Director William Casey.
2. Register Guard, Eugene, Oregon, 3/24/85
CIA DIRECTOR OWNS CAPITAL CITIES STOCK, NOT IN BLIND TRUST.
Co-founded in 1954. Casey, SOVEREIGN MILITARY ORDER OF MALTA.
ABC FOR JOHN PAUL II? Casey protege of OSS WILLIAM DONOVAN, SMOM.
3. Newsday, 3/28/85 "CIA Director Wants to Place Capital Cities Stock in Trust". Casey has \$7.5 million interest in media outlets. Morton Halperin, former natl. security staff member, "A GOVERNMENT OFFICIAL SHOULD NOT BE PART OF THE NEWS MEDIA". 31 years too late to find out. Why didnt this come up at Casey hearings? Not blind trust.
4. Newsday, 3/19/85 On Capital acquisitions. Casey's companies. Founded. 7 TV and a dozen radio stations, a number of trade publications, 50 cable TV systems, 10 newspapers, several pennysavers, a monthly financial newsletter. Revenues of \$939 million 1984. From TV stations in such key markets of Phil; Houston; Hartford-New Haven, Buffalo, N.Y.; Raleigh, N.C. Fresno, Calif. Tampa, Fla.
It also owns Fairchild Publications newspaper group which puts out Women's Wear Daily, and its 10 daily newspapers include the STAR TELEGRAM, FT. WORTH, THE TIMES AND THE STAR in KANSAS CITY, the OAKLAND PRESS in Pontiac, Mich.

Capital Cities was founded by the late LOWELL THOMAS AND CIA DIR. WILLIAM CASEY.

TROUBLE IN WILKES-BARRE, PA. TIMES LEADER, Capital Cities was union busting, paper went on strike, started their own paper, CITIZEN'S VOICE.

5. Kansas City Times, 3/85 CIA was on FCC trying to get them to penalize ABC for broadcasting plot to kill Ronald Rewald. Casey wanted license renewal turned down. Solution, buy out ABC, no more CIA scandals.

Spotlight, 11/5/84, thought CIA Casey would be out of job because of Ronald Rewald connections. INSTEAD, ABC IS OUT FOR THE STORY.

6. NY Post, 3/26/85 THE DONALD TRUMP, ROY COHN CONNECTIONS.

Trump was buying up ABC stock for 1½ yrs, Roy Cohn his attorney. Merger of Capital Cities with ABC, Trump made \$47,000,000. William Simon (CBS) and Roy Cohn, Western Goals, LA Olympics, J. Singlaub, CIA

7. HOWARD HUGHES, MR. CIA, WANTED TO BUY ABC IN 1968, OWNED 1.6 MILLION SHARES, \$200,000,000 investment.
CITIZEN HUGHES, Michael Drosnin, Holt, Rinehart, Winston. 1985.

Robert Maheu, FBI and CIA counter-intelligence, Hughes agent for deal. Greg Bautzer, both ABC and Howard Hughes attorney, working out ABC deal. FCC demanded HUGHES APPEAR IN PERSON TO CLAIM THE LICENSE. IMPOSSIBLE!!!! Hughes, "this will bring into sharp focus all the rumors of my death, disability, etc, etc. People will say that the reason the deal fell through was my unwillingness to appear". (Nobody cared if he was dead!!)

ABC would have been sold to "dead, disabled" if FCC allowed.

8. HOWARD HUGHES, John Keats. NYT 7/10/66, two years before ABC ATTEMPTED BUY.

Hughes in tightly guarded Bel Air mansion, no longer makes movies, designs planes, or controls patent to oil-drilling bit. He has surrendered ownership of Hughes Aircraft, he recently gave up struggle to recover control of TWA, selling shares for \$566,000,000 cash.

(Ready to buy ABC in 1968? Hardly. Howard never seen again, only CIA)

MURDOCK IS BUYING 50% of 20th CENTURY FOX. NYT 3/21/85

Rupert Murdoch, who bought Chicago Sun, \$55 million, "no more Meese, Grenada" EMPIRE FROM AUSTRALIA, LONDON, TO USA. AMERICAN SUBSIDIARIES 10 COMPANIES: New York Post, Boston Herald, Express-News, Village Voice, Chicago Sun-Times, San Antonio, Express, The Star, New York Magazine, New Woman mag., Travel Weekly, and 10 other magazines from Ziff-Davis Nov. 1984.

London Times, 28 British companies, 50 Australian companies. 27 newspapers.

REV. SUN MYUNG MOON, NEWSDAY, 3/28/85 "THE MAINSTREAMING OF THE REV. MOON"
