WHY WHITE HOUSE CHIEF OF STAFF DONALD REAGAN HAD SO MUCH POWER, TOOK CONTROL OF WHITE HOUSE AND NSC POLICIES:

London Stock Exchange, 3/2/1986, Merrill Lynch blackballed from the management committee of London Stock Exchange because of "long history of disreputable practices such as churning of accounts, unwarranted buy-and-sell transactions to alter value of accounts". Regan's 12 year reign "disreputable".
2. Donald Regan personally, Merrill Lynch, at center of control of \$400 billion flow of narcotics revenues, acting as America's #1 drug bank, protector of drug laundering.
3. Wanting to be SECRETARY OF TREASURY, D. Regan funded both JIMMY CARTER, R. REAGAN.
4. 1981 appointment of D. Regan, by R. Reagan, as TREASURY SECRETARY. U.S. Treasury largest influence on US financial policies. U.S. banking system BECAME DEPENDENT upon liquidity acquired from illegal narcotics revenues.
5. Business Week, 3/18/85 on Organized Crime, how bankers assist narcotics trafficking.
6. 6/13/85, Atty. Gen. Edwin Meese letter to Vice-Pres. George Bush on laundering money from drug traffic, "making cash for criminal activities".
7. MERRILL LYNCH MERGED SWISS CREDIT SUISSE WITH WHITE WELD CONNECTION, BOSTON BANKING. 1978, under Don Regan's chairmanship of ML, joined White Weld, Credit Suisse.

Zurich-based Credit Suisse now dominates \$140 billion - a -year Euro-dollar mkt. Hot havey for hot money, unreported cash transactions. Violations.
8. Nov. 1984 by PRESIDENTS COMMISSION ON ORGANIZED CRIME, titled "THE CASH CONNECTION, ORGANIZED CRIME, FINANCIAL INSTITUTIONS, AND MONEY LAUNDERING" identified Don Regan's Merrill Lynch as opening its doors to dope mafia, the "PIZZA CONNECTION", a Sicilian mafia network starting in 1981. This stretched from PALERMO TO MILAN, TO NEW YORK, NEW JERSEY, via Pizza parlors, flooded with narcotics from GOLDEN CRESCENT, HEROIN FROM IRAN, AFGHANISTAN, AND PAKISTAN".
9. At least \$4.9 million for SICILIAN MAFIOSO FRANCO DELLA TORRE, starting in March 1982, became known as the "Pizza Connection", directly linked to MERRILL LYNCH.
10. DELLA TORRE, making deposits from Waldorf Astoria Towers to MERRILL LYNCH, had laundered more than \$20,000,000. According to the Crime Report, bags of money taken with help of top executives of MERRILL LYNCH, accompanied by security guards.
11. "PIZZA CONNECTION" linked to more than 100 murders, including GEN. CARLO ABLERTO DALLA CHIESA, CHIEF INVESTIGATOR of links of organized crime, drugs, and RED BRIGADES.
12. RED BRIGADES SET UP BY P-2, FRANCESCO PAZIENZA, HENRY KISSINGER, MICHAEL LEDEEN, CIA
13. MERRILL LYNCH Swiss accounts funded TURKISH MAFIA BOSS MASULLULU YASAR AVNO. Links to Ali Mehmet Agca, Michael Ledeen, Frank Terpil, Theodore Shackley, P-2.
14. MURDER OF MICHELE SINDONA, "GOD'S BANKER", cyanide in Italian jail, linked to Pizza connection. Sindona partner of SECY. OF TREASURY DAVID KENNEDY, NIXON ADMINISTRATION.
15. Cash from MIDDLE EAST, DEPOSITED BY CREDIT SUISSE, Congressional Record, 7/27/85, tied to TWA Flight 847 hijacking, excuse for NSC, Reagan arming Khomeini.
