Harvard U., honors for RICHARD VON WEIZSAECKER, president of Germany, son of ERNEST VON WEIZSAECKER, Adolf Hitler's top diplomats, defended by son, Nuremberg. WEIZSAECKER appointed to personal staff of Heinrich Himmler, Waffen SS, Death's Head.
San Jose City College, REP. TOM HAYDEN graduation speech canceled.
FORMER SAIGON police, Vietnamese, forced Hayden to back down, bowing to pressure.
Evicted refugees from dictatorships will determine what graduates will hear?

BRITTON SCIORONI, ATTORNEY FOR WHITE HOUSE, PRESIDENT'S INTELLIGENCE ADVISORY BOARD.
Testimony June 8, 1987, on his "legal opinion, for North, McFarlane, Boland didn't apply to NSC"

UCLA law school. Worked Hoover Institute for Mr. Cambell, one of three on Board.
Failed four bar exams, 2 in Calif., 2 in DC. Finally told, "go to Penn."
Job waiting for him. Commenced 1 day after taking bar exams, months before passing.
Salary \$62,000 year. Never practiced law, never in court. Office, himself + a secretary.
Asked "Ollie" did you break law? After 5 minutes, satisfied all was OK.
Locked up his "legal Boland Amendment, OK for NSC to ignore" in a safe, never seen again.

"BUSH IMPLICATED" Jack Anderson, 6/8/87

Bush in Jerusalem July 29, 1986. Arms for hostages conversations with Amiram Nir.
Bush links to Max Gomez-Felix Rodriguez, discussions of arms for Contras.

Key to Bush story. SFC 8/25/87 William Hetrick, Edwin Wilson's son, cocaine charges and Hetrick's son. Goes to Klaus Barbie, Enterprise.

SECURITY CONTRACT ALMOST ACHIEVED BY ALBERT HAKIM, GEN. R. SECORD, FOR U.S. CAPITAL, CONGRESS.

A. Hakim working hard to help North "get hostages out for 1986 elections, Congress.
Reagan, Spitz Channell, would do media blitz, prove humanitarian concerns.

"ERNIE GARCIA, Sergeant at arms for the SENATE, asked Secord and STANFORD TECHNOLOGY to assess US Capitol security needs. The SENATE WAS READY to grant a contract for CAPITOL SECURITY. Now dormant, Senate changed hands, from Republican to Democratic"

1. Ollie North was known by the code name "GREEN" Carl Spitz Channel "GREEN MEETINGS".

2. GREEN also means money, THE ENTERPRISE, that would never die, be kept going.
Testimony of Albert Hakim, if died would leave Ollie \$2,000,000 to keep ENTERPRISE.
3. WILLARD ZUCKER, Swiss controller of ENTERPRISE FUNDS, LAKE RESOURCES, DUMMY FRONTS.
Used by NSC, presents White House team, former worked with Internal Revenue, USA.
4. WILLARD ZUCKER partner with ROBERT VESCO, and that meant money, many millions.

5. RONALD REAGAN'S PRESIDENTS FOREIGN INTELLIGENCE ADVISORY BOARD included ROY COHN, formerly on board of WESTERN GOALS, run by Carl Spitz Channell and EDWARD BENNET WILLIAMS, attorney for ROBERT VESCO, and ALFRED BLOOMINGDALE.
6. ALFRED BLOOMINGDALE SHARED VICTI MORGAN with BERNIE CORNFELD, whose Swiss accounts were taken over by WILLARD ZUCKER IN SWITZERLAND.
7. ALBERT HAKIM HAD BESTY NORTH, OLLIE'S WIFE, meeting WILLARD ZUCKER in Phil. for provisions of cash, \$200,000, while Ollie at NSC working for REAGAN.
8. ROBERT VESCO IS ALSO the partner with CARLOS LEHDER RIVAS, Columbia cocaine king, and PABLO ESCOBAR, JORGE OCHA, defedants with HAKIM, SECORD, CLINES, in Cristic suit charging Contras with drug dealing, assassinations, planned coup.
9. ESCOBAR, OCHA, RIVAS, deposited cocaine profits in MERRILL LYNCH, NY, while DONALD REGAN WAS STILL CHAIRMAN, just before being Secy. of Treasury, Chief of Staff for Reagan
10. CARLOS LEHDER RIVAS, KNOWN AS "GREEN". Published newspaper in green ink, on green, in Columbia. ARDENT NAZI, praised Adolf Hitler, defended drug traffickers, fanatic environmentalist, denounced polution. Prepared to clean up the world.
11. After \$10,000,000 of BRUNEI located, Albert Hakim testified that the Contras were to "get \$3,000,000 of it". He was going to keep "7,000,000?". A lot of green.
12. Missing \$8,000,000 from sale of arms to Iran, the profit handled by WILLARD ZUCKER and ALBERT HAKIM, located from "all over the world", according to Hakim. Now located in "LONDON ACCOUNT OF MERRILL LYNCH". THE ENTERPRISE IS A CLOSE-KNIT FAMILY
13. EDWIN WILSON, former partner of ALBERT HAKIM, GEN. R. SECORD, THOMAS CLINES, brought back to USA for arrest by ERNEST VON KEISER, formerly of Hitler's Wehrmact, "friend" of Wilson's. KEISER shot in shoulder, Wash. D.C., carrying papers about ROBERT VESCO. Fled to Germany, there now.

 Testimony at hearings, "Only Hakim could draw money out".
 Secord's signature missing from any document. Ollie used Hakim".
 "Zucker came to Switzerland in 1970, to take over IOS, INVESTORS OVERSEAS SERVICES, after ROBERT VESCO TOOK IT OVER".
