1. 12/8/81, Executive order signed by Reagan, that he would "regulate intelligence activities." NSC shall act as highest Executive Branch entity, to conduct all national foreign intelligence, counterintelligence, and special activities, and attend policies and programs".
2. 8/16/85, letter from Rep. Michael Barnes, D. Md. to NSC, warning about Boland Amendment because NSC took over all intelligence responsibility.
3. 11/85, NSC and Reagan hired BRETON SCIARONI to write answer to charges by Barnes. worked under PIOB, President's Intelligence Oversight Board.
4. 3/5/87 Rep. Henry Gonzalez filed ARTICLES OF IMPEACHMENT, to quietly have them on the books, as did Rep. Peter Rodino, when Watergate impeachment papers filed.
  1. Violation of Arms Export Control Act, acquiescing to Israeli arms to Iran.
  2. Violation of Foreign Assistance Act, allowing CIA to use fronts for weapons to Iran.
  3. Violation of National Security, Arms Export Control Acts, not notifying Congress.
  4. Violation of Section 509, Public Law 99-399, arms sales to "Terrorist Iran".
  5. Violation of Boland Amendment, failed to prevent diversion of funds to contras.
  6. Violation of "constitutional duty to take care laws faithfully executed".
