Jim Garrison for conspiracy to kill President J.F. Kennedy. Gov. R. Reagan would not extradite Bradley. "It would deny validity of Warren Report".

1. DR. WALSH, Beverly Hills, formerly of Mayo Clinic, "Reagan mentally sick" could lead to serious consequences for USA, world. Expertise, diagnosis for heads of govts.
2. RONALD REAGAN offered to submit to mental tests if he seemed senile or slipping.
3. REAGAN HAS HAD TWO CANCER OPERATIONS, growing tumors every year, getting weaker.
4. A PRESIDENT THAT CAN'T SPEAK SPONTANEOUSLY ON SERIOUS, OR EVEN PERSONAL MATTERS.
5. Necessity to use 3" x 5" cards at VENICE SUMMIT, even with close friends, and couldn't stay awake. Diverted from selected topics like 1986 "Libya", 1987 "Gulf".
6. Indicates no anger with cabinet, staff, for IRAN/CONTRA events, simply smiles.
7. National Security, NSA equipment, files given to Ayatollah Khomeini, secret coders with private citizens, no concern to PRESIDENT REAGAN, security no problem.
8. REAGAN allowed atty. Thomas Green access to Justice Dept., halt Miami, Contra Southern Air, drug traffic into USA to be investigated, while pushing "no drugs".
9. REAGAN relegated authority to his "team", cabinet, but when they objected to a quick decision to "flag Kuwait ships", then he made the decision, against GOP.
10. Policy towards IRAN changed too many times, too many versions. NOW WANTS WAR.
11. Iraq pilot hits USS STARK, REAGAN BLAMES IRAN. The man is crazy and dangerous.
12. A CORNERED ANIMAL LIKE REAGAN CAN CREATE A WAR AS DIVERSIONARY.
 - A. Ollie North, Alamo style massacre, was suggested to "INVADE NICARAGUA".
 - B. CONTRA PLANS TO KILL AMB. L. TAMBS, COSTA RICA, for "INVADE NICARAGUA"
13. REAGAN, groomed for ARMAGEDDON, with EDWIN MEESE, JERRY FALWELL, AND PENTAGON.
14. REAGAN always had FDR COMPLEX, COMMANDER-IN-CHIEF, THIRD TERM, IN TIME OF WAR.
15. Nomination of ROBERT BORK for Supreme Court, who fired President Nixon's Special Prosecutor, and has the AUTHORITY TO UNDERCUT REAGAN'S TEAM MEMBER'S PROSECUTION AND THE IRAN/CONTRA CONVICTIONS. Edwin Meese, Michael Deaver, Lynn Nofziger.
16. SFX 7/5/87 "REAGAN SENT AMERICAN FLAG FROM THE U.S. CAPITOL TO KUWAIT, to Abdul Fateh al-Bader... to save the US from investigations if war were to start.

1. "Martial law plan was drafted 1984"
Squad 19, IAPD, 1970 for 1972.
Martial Law plan began with Pentagon-Reagan, GARDEN PLOT.
2. "Lt. Col. Oliver North helped with 1984 plans"
OLIVER NORTH would instigate the operations that necessitated Martial Law, Middle East, Central America.
3. "Atty. Gen. William French Smith was opposed to the plan, EXECUTIVE ORDER 11490, creating an Emergency Czar"
William French Smith resigned as Attorney General, to go back to Rockwell Intl. (DEFENSE DEPT. PART OF THE PLANS) and turn Justice Dept. over to EDWIN MEESE, PART OF THE PLOT
4. "The Constitution would be suspended, military commanders would run state and local governments, martial law would be declared in event of nuclear war, widespread dissent, NATIONAL OPPOSITION TO U.S. military invasion abroad".
Operation Chaos, Cointel-pro, MK-Ultra used on opponents to policies. Planned invasions of Afganistan, Angola, Palau, Philippines, Panama, Nicaragua, or anywhere else prepared.
5. "North's proposal to radically alter American Government by EXECUTIVE ORDER in a time of crises is evidence of his involvement in a wide range of affairs."
Ronald Reagan's SYMBIONESE LIBERATION ARMY was a FBI, CIA, Defense Dept. operation in preparation for future Oliver North's. He just happened to be selected from Vietnam, Phoenix Program, where backbone of SLA came from.
6. "North was at the center of what amounted to a secret government within a govt"
Starting in 1971, HENRY KISSINGER, NSC, CHANGED GOVERNMENTS. This "secret team" got muscle when JFK, RFK, MLK buried. Kissinger, Fritz Kraemer, Robert McFarlane, A. Haig team.
7. "North was the liason from NSC to FEMA"
FEMA controlled by GENERAL LUIS GIUFFRIDA, who headed a National Guard training center in Calif. when Reagan Governor and EDWIN MEESE A NATIONAL GUARD BUDDY of LUIS. Jack Anderson, 9/1/84, 9/7/84, 9/9/84 on FEMA, Meese. M.H.
8. "Shortly after Reagan's inauguration the secret campaign group (who stole Pres. Jimmy Carter's papers, debate information, hostage facts, to get elected) had become a SECRET ADMINISTRATION GROUP, and was clashing with the bureaucracy, by Feb. 1981" (Bureaucracy being Congress) they began covert support for Contras.
March 30, 1981, President Reagan shot. John Hinckley's law office, Edward Bennet Williams, Mr. Sullivan, represent- in OLIVER NORTH in Iran/Contra affair. Also Vesco atty.
A. Haig "in charge". G. Bush, CIA director, as VP.
Jan. 1981 to July 1981, coups or plots in USA, Italy, Spain, Dominica, Ecuador, Bangladesh, Greece, India, and murders linked to CIA, NSC, business as usual. LICIO GELLI P-2 plot exposed, attended Reagan inauguration.
9. "Secret Team negotiations with ARGENTINA, where Gelli fled, to use Junta Death Teams to train Contras in Central America" GEN. LEOPOLDO GALTIERI IN WASH. D.C."
