MAY 29, 1986, Christic suit filed. Secord, Shackley, Hakim, Singlaub, Clines, Owen, Calero.
- JULY 17, 1987, North met with Robinette to discuss JACK TERRELL, former Contra co-worker, now assisting Christic. Asked Robinette to meet with FBI that evening.
- OLIVER "BUCK" REVELL, sr. FBI representative on NSC's "OPERATION SUB-Group "on terrorism.
- JULY 22, 1986, FBI report, DISCUSSION OF NORTH WITH 2 FBI about TERRELL.

NEW FBI DIRECTOR JUDGE WILLIAM S. SESSIONS, KEEPING THE TRADITION OF ASSASSINATION SURPRESSION, THE FBI AND THE OLD MEMBERS OF THE TEAM.

1. Gerald Ford, Warren Commission, then appointed U.S. PRESIDENT BY CROOK NIXON. 1975, Kansas Star and Times, about Rockefeller Commission on Political Assassinations, "Political assassination plots by the CIA should be kept secret because it would not be in the national interest to divulge it".

2. Ford appointed William Sessions to federal bench, Texas, 1974.

3. Crook Nixon, in Dallas, Texas, Nov. 20, 21, 22, 1963, appointed Ford to the Warren Commission and William Sessions as U.S. Attorney in 1971.

4. Sessions "strongly backed" by former Sen. John G. Tower, R. Texas

Sen. John Tower named by ROBERT BYRON WATSON, Hudson Valley Chronicle, July 1977, as being close to MR. CHRIST KAMETCHES, cocaine smuggling operation from South America, and "EVEN JOHN TOWER AND GOV. DOLPH FIRSCOW WORK FOR THE NARCOTIC ASSOCIATION (ENTERPRISE) WITH THE SYNDICATE".

5. Sen. John Tower and JFK assassination, Lee and Marina Oswald, Tape # 795, 3/2/87.
