"By Jan. 1984, Italian judge Carlo Palermo confirmed connections of heroin smugglers with arms and munitions to equip armies. Mafia-operated labs in Italy linked to importers in the USA. Bekir Celenc, involved. Ali Mehmet Agca identified CELENC as man who offered him \$1,000,000 to kill the pope."

HENRI ARSAN, a Syrian, key morphine supplier to French Connection, started working for UNITED STATES AND ITALIAN GOVERNMENT, trafficking in ARMS (weapons for Iran) and drugs. By 1981, A MILAN FRONT COMPANY CALLED STIBAM INTERNATIONAL TRANSPORT, Arsan was equipping terrorists, arming nations, and "THE REAL BUYER WAS IRAN".

"SHADOWY ARMY UNIT TIED TO FUNDS AIDING CONTRAS", LAT 4/25/87

Code name "YELLOW FRUIT", "shadowy, scandal plagued Army intelligence unit. \$75,000 taken from this account by North, Hakim, Secord for Danish freighter, EERIA. Bank account at CREDIT SUISSE, GENEVA. Boston Bank and Merrill Lynch control C. SUISSE. (TIC, Otto Von Bolschwing, links to funds, BOSTON BANK)

This bank account UNAUTHORIZED BY DEFENSE DEPT. AND ARMY COMMAND. PENTAGON CANT SAY HOW MUCH MONEY PASSED THROUGH THE ACCOUNT, WHETHER FUNDS FROM ARMY SOURCES OR FROM SOME OTHER SOURCE.

Pentagon WILL NOT INVESTIGATE, LEAVE IT TO LAWRENCE WASH. Established "fall of 1982." Pentagon, Army, FBI, federal prosecutors and OTHER ORGANIZATIONS investigated the unit, never discovered the SWISS BANK ACCOUNT. The Pentagon doesnt know HOW MANY AUTHORIZED TO DRAW FUNDS. Offices ANNANDALE, VA. Cover organization BSI, BUSINESS SECURITY INTERNATIONAL.

"ARMS STING SABOTAGED, SUIT ALLEGES, BECAUSE OF IRAN-CONTRA LINKS" Houston Post 8/31/87

GARY HOWARD and RON TUCKER, employed by TREASURY AND CUSTOMS, assigned to "get" IAN SMALLEY. Smalley, "Dr. Doom", sending arms to Iran. Also funded by Shah group in USA, willing to spend \$120,000,000 to get rid of Khomeini.

TUCKER AND HOWARD STARTED PEREGRINE, FOR DEFENSE DEPT, 1981, DALLAS. They claim US govt. owes them \$1.4 million. When they got Smalley's operations, US called off prosecution, hushed it up. "THEN SECY. OF TREASURY DONALD REGAN KNEW ABOUT AND SUPPORTED THE OPERATION".

1980, JUDGE CARLO PALERMO investigated a secret HEROIN warehouse.

This inquiry led to the illegal trade in SMALL ARMS, morphine to Italy from Middle East. In return, small arms and rifles sent to terrorists.

By NOVEMBER 1982, JUDGE PALERMO got into the big shots, HEROIN, WEAPONS SALES.

May, 1981, P-2, Licio Gelli, fascist connections broke open.

June, 1982, Robert Calvi murdered, Banco Ambrosiano, Vatican.

PALERMO CAUGHT UP WITH HENRI ARSAN FROM SYRIA. Arsan in Calvi's building, Milan. ARSAN supplying weapons to IRAN, for CIA, DEFENSE INTELLIGENCE AGENCY.

1979-1980, Maj. Gen. Meadows (Pelegrene pres.), Lt. Col. Oliver North, Maj. Gen. Secord and Albert Hakim on "fatal rescue mission in Iran".

The Pentagon opened a SOD, Special Operations Division, brainchild of CIA, away from Congress. "YELLOW FRUIT", Credit Suisse, financed illegal GROUPS, USING LAUNDERED MONEY from SALE OF BOTH ARMS AND NARCOTICS.

BERNARD VEUILLOT, arms dealer, told PALERMO about 3 American secret services, CIA, DIA, NATIONAL SECURITY AGENCY, transporting weapons to IRAN. TRADE, ARMS FOR NARCOTICS.

The US Embassy in Rome, certain senior staff involved. They wouldnt be questioned.

REAGAN'S "PROJECT DEMOCRACY", initiated in 1982, became linked to HENRI ARSAN'S group.

"Project Democracy" profits for Contras, MILITARY SUPPLIES FOR IRAN through TALAMONE. OPERATION DEMAVEND, named for mountain in IRAN, sent more than 2000 million of equipment to IRAN.

Veillot, with CLAUDE LANG, French weapons dealer with links to CIA, set up the DALQA FINANCE COMPANY in Panama, supplying arms to Teheran.

HENRI ARSAN died in San Vittore prison, Milan. Calvi and Michele Sindona soon died.

By APRIL, 1983, JUDGE CARLO PALERMO WAS WORKING WITH GLAUCO PARTEL, who had been arrested. PARTEL, LIKE ARSAN, WORKED FOR AMERICAN SECRET SERVICES. He had top secret NATO information. PARTEL TOLD PALERMO about how the selling of weapons functioned, and about AMERICAN SECRET SERVICES, CIA, DIA, and how the fund was used to affect elections, such as in Italy.

PARTEL had a press conference, L'Espresso, 11-30-86, in Rome, where he talked and confirmed JUDGE CARLO PALERMO'S FINDINGS. ITALY'S TALAMONE PORT USED FOR ARMS SHIPMENTS TO IRAN, FROM CIA, OTHER CIA OPERATIONS.

TAPE # 678 DECEMBER 10, 1984 LINKS OF P-2, NUGAN HAND BANK, MASONIC LODGE, VATICAN, ARMS, AND DRUGS.

Le Matin, 6/20/84 "GLAUCO PARTEL, Rome engineer, worked for NSA, US agency. Partel, Rome engineer, associated with EUGENE BARTHOLOMEUS, SYDNEY AUSTRALIA. Bartholomeus is the NUGAN HAND BANK CONNECTION, ONE OF MANY, TO Oliver North, R. Secord, Theodore Shackly, Thomas Clines, Task Force 157, etc.
