HEARINGS FOR JUDGE BORK, SUPREME COURT, SENATE JUDICIARY .

1. CNN turns off William Coleman, Barbara Jordan. Two BLACKS AGAINST BORK APPOINTMENT, both denied audience for their concerns. TV turned to Reagan, regular programming. Call CNN news, Mr. Krieg, 404 - 827 - 1800

2. WILLIAM COLFMAN, former Secy. of Transportation, atty. for WARREN COMMISSION, BLACK. SEN. ARLEN SPECTER, CIA atty. for WARREN COMMISSION, JEWISH.

Both now worried about Bork, Supreme Court. They covered NAZI ROLE IN JFK ASSASSINATION.

3. SEN. E. KENNEDY, praised COLFMAN, "you made this a better country", lots of praises. Coleman covered up Kennedy's assassins, who still are free, killing more.

4. "BORK VS. FOI ACT", Jack Anderson, 9/18/87

Meeropol vs. Meese, the children of Julius and Ethel Rosenberg were denied documents of FBI regarding their parent's case, possibly being framed. Bork said, "FBI's withholding of these documents was proper".
