WHO SOLD OUT THE USA TO THE DRUG DEALERS?

1. WORLD WATCHERS, # 795, March 2, 1987 HOW DONALD REGAN GOT CONTROL OF WHITE HOUSE.  
 15 links of MERRILL LYNCH, CREDIT SUISSE, TO DRUG MONEY, WEAPONS, TERRORISTS, ASSASS.  
# 13 "MERRILL LYNCH, Turkish mafia boss YASAR AVNO MASULLULU, and ALI MEHMET AGCA"
2. CORRIERE della SERA, 6/18/87 ITALY, COVERING THE "PIZZA" TRIAL.  
 Turkish dealer, PAUL WARIDAL, testified that between 1981 and 1983 ORAL CELIK  
 used the name of YASAR AVNO MASULLULU. CELIC indicted for part of assassination  
 plot against POPE JOHN PAUL II, along with AGCA.
3. LA REPUBBLICA, 7/25/85 FROM ITALY,  
ORAL CELEK, alias YASAR MASULLULU, is believed to have worked for U.S. DEA.  
 Some of Agca's accomplices, such as OMER AY, were busted, Germany.
4. "TRIAL IS TOLD DRUG SUSPECT RECEIVED MILLIONS IN CASH" NYT 4/1/86  
 Brokerage firms of E.F. HUTTON, MERRILL LYNCH, sent laundered Mafia HEROIN MONEY  
 to Switzerland, to PAUL WARIDAL. He collected more than \$11,000,000 for  
 a Turkish drug dealer, delivered in Lugano and Zurich, at his home, for YASAR  
MASULLULU.  
 In Sept., 1982, an official from E.F. HUTTON DISCLOSED THAT THE FBI (under W.  
WEBSTER, NOW CIA DIRECTOR) was "getting interested in our account in the USA. They  
 were to use other methods of deposit".  
Franco Della Torre was delivering millions of case to the NY firms, Wall St.
5. ORAL CELIK, AKA YASAR MASULLULU, AND HOW HE CONNECTED WITH AGCA, WITH POPE SHOOTING.  
 Covert Action, Volume #23, Spring 1985, pages 9-12 on ORAL CELEK.  
 After AGCA killed Abdi Ipecki, Turkey's most prominent editor, CELIC GOT AGCA  
 out of jail. MEMBERS OF FASCIST GRAY WOLVES ASSISTED. Money for CELIC COMING  
 FROM MERRILL LYNCH AND E.F. HUTTON.
6. 1979, AN IMPORTANT YEAR. IMPORTANT JOB SHIFTS, AND A MEETING OF TOP PLANNERS.  
 1979, Merrill Lynch and E.F. Hutton started sending heroin profits made from  
 drug sales in USA to Switzerland, account of Paul Waridal and Oral Celik.  
 1981, Pres. R. Reagan inaugurated. JIM BAKER, G. BUSH'S man and campaign director,  
 became CHIEF OF STAFF, GUARDING THE WHITE HOUSE DOORS AND PHONE.  
 George Bush's brother-in-law's firm, E.F. HUTTON, WHERE SCOTT PIERCE WAS CHAIRMAN,  
 was sending narcotics profits to Waridal and Celik. Bush was CIA Director.  
Don Regan, former chairman of MERRILL LYNCH, was now Secretary of Treasury.  
 It is the Treasury job to report, investigate money skimming of drug dealers.  
 Suddenly, JIM BAKER BECAME SECRETARY OF TREASURY, now able to block investigations  
 for Bush of his wife, Barbara's brother, who were reaping profits from drug funds.  
DON REGAN BECAME CHIEF OF STAFF, GUARDING THE REAGAN PHONES, VISITS, MESSAGES.
7. FEBRUARY 1, 1979, ALI MEHMET AGCA "KILLED" ABDI IPECKE,  
 NOVEMBER 23, 1979, BEKIR CELIK, financial partner with WARIDAL, GOT AGCA OUT OF JAIL.  
 DECEMBER, 1979, AGCA SENT TO LIBYA, TO LEARN TO SHOOT, KILL, WITH CIA FRANK TEPRIL.
8. JULY 2-5, 1979, FIRST MEETING OF JONATHAN INSTITUTE, ISRAEL, ON "TERRORISM"
