Oliver North, planner of diversion, with CIA WILLIAM CASEY. NORTH of Marines, Seals. North, former "PATIENT", mind experiments of some kind in service, even later.

"NIGHTMARE AT THE PRESIDIO", Channel #2, Sunday, 4/10/88 One hour on molestation cases.

Section on Michael Aquino, still being investigated for "CHILD STEALING, CHILD NEGLECT, CHILD ABUSE, MOLESTATIONS AND RAPES. Drug operators paid US officials for radio frequency of AIR FORCE ONE, PRESIDENTIAL JET. Listened to conversations, "knew what they were talking about".

Used flights of SPACE SHUTTLE CHALLENGER AS COVER FOR OPERATIONS. Coast guard busy. William Rogers, invest. of CHALLENGER. Also atty for Panama's President E. Delvalle, and . . . A.
