- 3- 85 Chester Arthur Building that housed Immig. Sefvices bought by BENDER FAMILY for \$37.5 million, twice the assessed value. Govt. lease going to expire soon.
- 6- 85 Complaints of illnesses of employees, GSA got promise from Benders to clean up the air circulation system, which they hadnt done when new lease signed.
- 6- 85 THREE MONTHS AFTER BUILDING PURCHASED BY BENDERS, JUSTICE DEPT. TOLD CONGRESS THEY WOULD NOT VACATE, BUT WOULD USE THE OLD BUILDING, WITH NEW OWNERS.
- Fall 85 THE BENDERS TRIED TO LOCATE A JOB FOR URSULA MEESE, WOULD PAY \$120,000,000, 3 yrs.
- 1-1- 86 URSULA MEESE started to work for MULTIPLE SCLEROSIS FOUNDATION, \$120,000,000, 3 yrs
- 5- 86 HUGE CONTRACT WITH JUSTICE DEPT., BENDERS TO GET \$50,000,000 rent for 10 yrs. on their new building, THREE TIMES THE PREVIOUS RENT, now health hazard.
- 5-14-86 13 days after signing new lease with JUSTICE DEPT., BENDERS SOLD THE BUILDING, ENHANCED BY THEIR NEW TENANT'S CONTRACT, FOR \$60,000,000. They made \$22.7 million on a two year investment. Taxpayers pay the inflated rent fees.

EDWIN MEESE ACCOUNT WITH CHINN FOR \$50,000 investments, CHINN SPENT \$140,000 for him. EDWIN MEESE made an 80% profit, up to \$90,000, buying and selling all WITHIN SAME DAY.

3. URSULA MEESE, WITH STOCKS IN BIO-TECHNOLOGY, GENETICS, ON BOARD OF MULTIPLE SCLEROSIS.
