Olson became ill with flu March 18.He had surgery 7 days later and died of colon cancer. "All of us are shocked at the suddenness of Jim's death".
- 2.WSJ 4/21/88 Day after the annual meeting."National alliance did garner 8.6% of the shareholder vote against 6% for recommitting to affirmative action.
- 3.SFX 4/21/88 Herbert Poinsett, of Norcross,Ga,on behalf of NATIONAL ALLIANCE, wants to "wake people up they are being displaced by people who are taking white jobs". They also voted down AN EVEN LARGER MARGIN ,A RESOLUTION CALLING FOR ADVANCEMENT OF MORE WOMEN AND MINORITIES IN MANAGEMENT". "We lost one battle,war is started".

World Watchers #840, 1/11/88 on JEB BUSH,LYNN NOFIZER,medical "care"for Cubans, Haitians,10,000 automatically enrolled into program.DANGEROUS POSSIBILITIES HERE. LAT finally printing part of the Miami Herald story,Santos Trafficante,R.Vesco links.

"FREED PRISONER CALLS ON JUDGE" M.H. 4/17/88

Licio Gelli,released from jail,paid curtesy call on JUDGE ANTONIO PIZZA,the same judge who charged Gelli with 1982 collapse of Banco Ambrosiano,Italy's largest bank. Gelli,builder of NAZI ESCAPE ROUTE "RAT LINE",Waffen SS,Italian Gestapo,Franco army. Long associate of JUAN PERON,ARGENTINA.Head of P-2,alligned with coup,death squads.

Sirhan family left Lutheran church, recruited by GREEK ORTHODOX CHURCH,CIA conduit. Brought to USA 1965. Sirhan's father "plumber in NYC",defense dept.job,one year. Went back to Jordan,bought large home, 50 acres,and 2 other residences.

Mrs.Sirhan,sons,bought a home in Pasadena,Calif.Brought to Calif.by friends of Richard and Pat Nixon,worked for them. The church that brought them here later gone.

The doctor and his wife had died,the other couple who arranged job,disappeared. This mysterious family prominent in Pasadena society,active in GOP Party,and on Rose Bowl Committee with Richard Nixon.Close college friends. FBI interviews with the families have never become public record.

TAXPAYERS BILL OF RIGHTS, with more than 20 SECTIONS.

IRS would have to inform you of your rights prior to tax proceedings.
You would be allowed an attorney to attend and RECORD MEETINGS.
Make it illegal to promote IRS agents on quotas of "people they get".
IRS WOULD EXTEND 10 day to 30 day notices before seizing your property.
Taxpayers would be allowed to SUE THE IRS FOR DAMAGES and repayment of legal fees.

INSLAW

A small software company that got a \$10,000,000 contract with the Justice Dept. in 1982.
Owned by Bill Hamilton, founder, who put his life, life savings into this project.
PROMIS, Prosecutor's Management Information System, is what Justice Dept. wanted.

THE MYSTERIOUS TURN

After approval of the contract, the business started falling apart.
Contract disputes, threats, money held up from DC Justice Dept.
After years of PROBLEMS, Hamilton discovered the Justice Dept. agents put his
invoices into a drawer with the intention of not only bankrupting the company,
but of forcing its LIQUIDATION.

Those people doing this were the RONALD REAGAN, CALIF. MAFIA FROM ALAMEDA, THE EARLY TEAM.

JUDGE GEORGE BASON

"The Justice Dept. purposely propelled INSLAW INTO BANKRUPTCY in an effort to
STEAL ITS PROMI SOFTWARE through TRICKERY, FRAUD, AND DECEIT".

Feb. 2, 1987, Judge Bason ordered Dept. of Justice to repay INSLAW \$1,000,000 plus
\$6.5 million, possible \$25,000,000 punitive damages. One month later, Judge Bason fired.

In the past 4 years, only 4 of 136 bankruptcy judges removed, turned out.

THE JUSTICE DEPT. ENEMIES WITHIN, pushing to steal PROMIS, hurry the takeover.

C. MADISON "BRICK" BREWER oversaw the INSLAW CONTRACT.
Brewer had been fired by Hamilton's company in May, 1976.

D. LOWELL JENSEN, Deputy Attorney Gen. who competed and lost a Justice computer contract
while Jensen a D.A. in Alameda with Edwin Meese.
